AND AMENDMENT OF 2024 BUDGET, IF NECESSARY**

A public hearing on the proposed 2025 budget and to amend the 2024 budget, if necessary, will be held at a regular meeting of the Board on November 20, 2024 at 9:00 a.m., at the District office located at 130 Second Street, Monument, CO. Any interested elector of the District may inspect the proposed budget and budget amendment and file any objections thereto at any time prior to the final adoption of the budget.

- Paper Panties
- Tampons, Applicators or Pads
- Cotton Balls
- Cotton Swabs
- Makeup Sponges

Disposable household products, such as:

- Cat Litter
- Paper Towels
- Toilet Brush Heads
- Mop Heads



These products can cause expensive backups of your sewer service line, district sewer main lines and damage to pumps at the district lift stations and wastewater treatment facility.

Do not flush any unused prescription drugs. Call your pharmacy for instructions on how to dispose of them in the garbage or drop them off at the local police station.
